Guidelines

Funding for the Outreach Committee comes from designated funds which are a part of the Endowment Funds of First Presbyterian Church. These designated funds came from individuals who wished to see the funds used to strengthen and grow the Christian community in our County, New York State and around the world.

Governance Related to Funding Requests

Outreach Committee's function is to review applications for funding and make recommendations to Session for funding. Session is the ruling body for First Presbyterian Church and is made up of members of the congregation. Outreach Committee meets the second Sunday of each month except July and August. Recommendations from Outreach Committee go to Session for approval. Session meets the third Thursday of each month.

Applications

Applications are available online at www.watertownfirstpres.org (click on Mission) or call the church at 315-782-1050 or email Linya Bell at linyab@msn.com. When applications are received the Committee Chair will review and decide whether a personal presentation would be helpful. If this is deemed necessary then Chair will arrange for applicant to attend an Outreach Committee meeting.

Applications typically take 1 to 3 months to gain approval. Chair of the Outreach Committee will communicate the decision to applicant once Session has met and reviewed the recommendation from the committee.

Mission and Vision

It is important to review the mission and vision of First Presbyterian Church in order to ensure the program for which you are requesting support fits with the direction of the church.
